## CLIMATE CHANGE



- We are committed to reaching zero net scope 1 and 2 emissions by 2050.
- We have set an actionable and concrete, short-term goal to reduce scope 1 and 2 emissions by 35% before 2025, and a mid-term goal to reduce scope 1 and 2 emissions by 40% before 2030.
- We assess the risks associated with climate change continuously and implement climate change mitigation and adaptation measures in our operations.

## **ENERGY TRANSITION**



We constantly monitor technological, market and regulatory developments to identify low-emission initiatives that could be a good fit for our portfolio and capabilities.

## BIODIVERSITY



- We apply a mitigation hierarchy in the use and protection of biodiversity.
- We assess the impact on biodiversity in the project planning of our projects.
- We avoid operating in legally protected biodiversity areas.
- We work toward no deforestation and no biodiversity net loss, recognizing our dependencies on nature.
